## **CHILDREN’S ONLINE PRIVACY ACT (“COPPA”) NOTICE**

*Effective Date: December 14, 2020*

Colliga Apps (“Colliga,” “we,” “us,” or “our”) is committed to privacy and data protection. The Children’s Online Privacy Protection Act of 1998 and its rules (collectively, “COPPA”) require us to inform parents and legal guardians (as used in this policy, “parents” or “you”) about our practices for collecting, using, and disclosing personal data from children under the age of 13 (“children” or “child”) through the use of our applications or affiliated research studies (“Services”). ## **How Does Colliga Use Children's Personal Data?**

Colliga uses children's personal data to provide Services through its mobile application or in affiliation with a research study, both of which Colliga has to obtain your express, verifiable parental consent for their use.

This may include communicating with the child several times, through video conferencing technology, such as Zoom, for which you would have provided your express consent, if this occurs.

We may use the non-personally identifiable data we collect to improve the Services and to deliver a better and more personalized experience.

Colliga retains personal data in a form which permits identification of a child for as long as necessary to provide the Services or Research Study in which the child is participating, or for other business purposes such as complying with our legal obligations, resolving disputes, and enforcing our agreements.

Colliga is required by law to keep some types of information for certain periods of time (for example, a statute of limitations).

### **When Do We Disclose Children's Personal Data?**

Colliga does not sell or rent children's personal data.

Colliga may disclose aggregated or de-identified data about many of our users when data that does not identify any individual or device. In addition, we may disclose children's personal data:

- If we are required to do so by law or legal process, such as to comply with any court order or subpoena or to respond to any government or regulatory request;
- If we believe disclosure is necessary or appropriate to protect the rights, property, or safety our company, our customers or others, including to protect the safety of a child, protect the safety and security of the Services; or enable us to take precautions against liability; or
- To law enforcement agencies or for an investigation related to public safety.

In addition, if Colliga is involved in a merger, divestiture, restructuring, reorganization, dissolution, or other sale or transfer of some or all of the Colliga's assets, whether as a going concern or as part of bankruptcy, liquidation, or similar proceeding or event, Colliga may transfer the personal data we have collected or maintain to the buyer or other successor.

### **How Can You Access, Review, and Update Your Child's Personal Data?**

At any time and upon providing proper identification, you may access and review your child's personal data maintained by Colliga, request that Colliga update or delete such personal data, and/or refuse to allow us from further collecting or using your child's personal data.

To protect your and your child's privacy and security, Colliga may require you to take certain steps or provide additional information to verify your identity before Colliga provides any personal data or makes any corrections.
